

THE BOROUGH OF EASTLEIGH (BURSLEDON, HAMBLE-LE-RICE AND HOUND) (AMENDMENT NO 7) ORDER 2017

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

1. This Order shall come into operation on 8 March 2017 and may be cited as the "Borough of Eastleigh (Bursledon, Hamble-le-Rice and Hound) (Amendment No 7) Order 2017".

Prohibition and Restriction of Waiting

2. In this Order the Principal Order means The Borough of Eastleigh (Bursledon, Hamble-Le-Rice and Hound) Consolidation Order 2012
3. The Principal Order is hereby amended as follows:
4. In the Fourth Schedule (No Waiting at Any Time) item number 5 relating to Bridge Road shall be revoked and replaced with:

5	Bridge Road	North-east	From a point 110 metres north-west of its junction with Bridge Close in a South-easterly direction to a point 54 metres South-east of Bridge Close.

5. In the Fourth Schedule (No Waiting at Any Time) as amended by The Borough of Eastleigh(Bursledon, Hamble-Le-Rice and Hound) (Amendment No 3) Order 2014 item number 10 shall be revoked and replaced with:

52C	Kings Field	Both	From the south eastern building line of No 24 Kings Field in a northerly and westerly direction for a distance of 41 metres, to include the access to the garage area south of 12a/14 Kings Field.

70c	Moorhill Gardens	South East and east	From its junction with Thornhill Park Road in a north easterly and northerly direction for a distance of 70 metres.

12. In the Fourth Schedule (No Waiting At Any Time) after item number 78 relating to New Road there shall be inserted:

78a	New Road	Both	From its junction with Grange Road in a south easterly direction for a distance of 23.5 metres

82B	Priory Road	North West	From a point 15 metres south west of its junction with St Edwards Road in a north easterly direction to a point 15 metres north east of that junction.
82C	Priory Road	South East	From a point 12 metres south west of the south-western junction of the access road

to Nos 6-24 Priory Road in a north easterly direction to a point 10 metres north east of that junction.

82D	Priory Road	South East	From a point 15 metres south west of the north-easterly junction of the access road to Nos 6-24 Priory Road in a north easterly direction to a point 12 metres north east of that junction.
82E	Priory Road, Access Road to Nos 6-24 Priory Road	Both	From its south-western junction with Priory Road in a south easterly direction for a distance of 9 metres.
82F	Priory Road, Access Road to Nos 6-24 Priory Road	Both	From its north-easterly junction with Priory Road on a south easterly direction for a distance of 9 metres.

Road in a north-easterly and easterly
