

THE BOROUGH OF EASTLEIGH (EASTLEIGH TOWN CENTRE)  
(AMENDMENT NO.X) ORDER 201X

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made under Section 19 of the Local Government Act 2000 with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

1. This Order shall come into operation on xxx and may be cited as the "Borough of Eastleigh (Eastleigh Town Centre) (Amendment No.X) Order 201X".

Prohibition and Restriction of Waiting

2. In this Order the Principal Order means The Borough of Eastleigh (Eastleigh Town Centre) Consolidation Order 2013
3. The Principal Order is hereby amended as follows:
  - (a) In the First Schedule (No Waiting at Any Time) item number 104 relating to Link Road between Stoneham Lane and M27 Junction 5 shall be revoked.
  - (b) In the First Schedule (No Waiting at Any Time) item number 105 relating to Link Road between Stoneham Lane and M27 Junction 5 shall be revoked.
  - (c) In the First Schedule (No Waiting at Any Time) after item number 205 relating to Steele Close (spur) there shall be inserted:

Stoneham Lane      Both sides      From its junction with Stoneham Way (Link Road) in a northern direction for a distance of 150 metres.

- (d) In the First Schedule (No Waiting at Any Time) item number 206 relating to Stoneham Lane Link Road shall be revoked and replaced with:

206	Stoneham Way (Link Road)	West side	From its junction with the M27 junction 5 roundabout in a northern direction to its junction with Stoneham Lane.
206i.	Stoneham Way (Link Road)	East side	From its junction with the M27 junction 5 roundabout in a northern direction (for a

206ii.	Stoneham Way (Link Road)	East Side	distance of approximately 183 metres) to the southern end of the layby. From the northern point of the layby (a point approximately 276 metres north of its junction with the M27 Junction 5 roundabout) in a northern direction to its junction with Stoneham Lane.

(e) In the Third Schedule (Waiting limited to one hour no return within two hours) item number 1 relating to Stoneham Lane Link Road shall be revoked and replaced with:

1.	Stoneham Way (Link Road)	East side	From a point approximately 183 metres north of its junction with the M27 junction 5 roundabout in a northern direction for a distance of 93 metres (the entire length of the layby).
