

**THE BOROUGH OF EASTLEIGH (BURSLEDON, HAMBLE-LE-RICE AND
HOUND) (AMENDMENT NO. 9) ORDER 2019**

The Council of the Borough of Eastleigh (hereinafter referred to as "the Council") pursuant to arrangements made with the Hampshire County Council in exercise of the powers of the said County Council under Sections 1, 2 and 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

Commencement and Citation

1. This Order shall come into operation on 29 April 2019 and may be cited as the "The Borough of Eastleigh (Bursledon, Hamble-Le-Rice and Hound) (Amendment No. 9) Order 2019".
2. In this Order the Principal Order means The Borough of Eastleigh (Bursledon, Hamble-Le-Rice and Hound) Consolidation Order 2012 as amended.
3. The Principal Order is hereby amended as follows:

Prohibition and Restriction of Waiting

4. Article 23A to the Principal Order shall be deleted and replaced with the following:

23A. Save as provided in Articles 31 and 33 of this Order no person shall except upon the direction or with the permission of a Police Constable in uniform or a civil enforcement officer cause or permit any vehicle to wait between the hours of 8:00am and 6:00pm on any day other than a Sunday on the sides of roads or in the lengths of roads specified in the Twenty Second Schedule to this Order-

 - (a) For a longer period than two and a half hours; or
 - (b) If a period of less than three hours has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle on those sides of road or in those lengths of roads.
5. The following shall be added as a new Article 27b to the Principal Order:
 - (1) Save as provided in Articles 31 and 33 of this Order no person shall except upon the direction or with the permission of a Police Constable in uniform or a civil enforcement officer cause or permit any vehicle to wait between the hours of 8.00am and 6.00pm on any day in the lengths of roads specified in the Twenty Sixth Schedule to this Order-
 - (a) for a longer period than 30 minutes; or

(b) if a period of less than 2 hours hour has elapsed since the termination during the said hours of the last period of waiting (if any) of the vehicle in those lengths of roads.

6. Article 40(c) shall be deleted and replaced with the following:

40(c) between the hours of 8:00am and 5:00pm on any day other than a Saturday or a Sunday in the roads specified in the Twenty Third Schedule to this Order.

7. (a) In the Fourth Schedule (No Waiting at Any Time) before item number 1 (relating to Beach Lane) there shall be inserted:

1i. Ash Close Both From its junction with Oak Road in an easterly direction for a distance of 8 metres

(a) In the Fourth Schedule (No Waiting at Any Time) after item Number 3 (relating to Beaulieu Road) there shall be inserted:

3a
Beaulieu Road Both From its junction with Hamble Lane north-eastwards for a distance of 10 metres

(b) In the Fourth Schedule (No Waiting at Any Time) after item number 15A (relating to Denzil Avenue) there shall be inserted:

15Ai. Dodwell Lane North West From its junction with Oakhill in an northerly direction to a point 18 metres south-west of its junction with Oakhill Close

(c) In the Fourth Schedule (No Waiting At Any Time) item 16 (relating to Ensign Way) shall be revoked and replaced with:

16. Ensign Way North West From a point 30 metres north-east of the vehicular entrance of South Point southwards to a point 10 metres south-west of that entrance.

(d) In the Fourth Schedule (No Waiting At Any Time) item 18B (relating to Ensign Way) shall be revoked and replaced with:

18B. Ensign Way South East From a point 18 metres north of the vehicle entrance to South Point 4 south wards to a point 10 metres south of the northern vehicular entrance to Mitchell Point.

(e) In the Fourth Schedule (No Waiting at Any Time) after item number 18B (relating to Ensign Way) there shall be inserted:

18C.	Ensign Way	North West	From a point 20 metres south of the access to South Point for 27 metres south-westwards

(f) In the Fourth Schedule (No Waiting at Any Time) after item number 38 (relating to Hamble Lane) there shall be inserted:

38A.	Hamble Lane	North East	From a point 3 metres north-west of its junction with Beaulieu Road in a south-easterly direction to a point 11 metres south-east of that junction.

(g) In the Fourth Schedule (No Waiting at Any Time) after item number 78 (relating to Portsmouth Road) there shall be inserted:

78iii.	Oak Road	East	From a point 7 metres north of its junction with Ash Close in a southerly direction to a point 7 metres south of that junction.

78iv	Oakhill	North	From its junction with Dodwell Lane in a westerly direction for a distance of 10 metres.

78v	Oakhill	North	From a point 26 metres north-west of its junction with Dodwell Lane in a north-westerly direction for a distance of 14 metres.

(h) In the Fourth Schedule (No Waiting at Any Time) after item number 94 (relating to Pylands Lane) there shall be inserted:

94ii.	Queens View	North West	From a point 12 metres north-east of its junction with Westwood Road in a south-westerly direction to a point 12 metres south of the junction.

94iii.	Queens View	South East	From a point 8 metres north-east of its junction with Sellwood Road in a south-westerly direction to a point 19.5 metres south-west of that junction.

(i) In the Fourth Schedule (No Waiting at Any Time) after item number 103A (relating to Sedgemoor) there shall be inserted:

103B.	Sellwood Road	Both	From its junction with Queens View in an south-easterly direction for a distance of 12 metres.

- (j) In the Fourth Schedule (No Waiting at Any Time) after item number 136C (relating to Victoria Road) there shall be inserted:

136D. Westwood Both From its junction with Queens View in a north-
Road westerly direction for a distance of 12 metres.

9. The following shall be inserted as a new Schedule 22:
