

**THE BOROUGH OF EASTLEIGH  
(HEDGE END, WEST END AND BOTLEY)  
(AMENDMENT NO. 6) ORDER 2019**

**NOTICE IS HEREBY GIVEN** that the Eastleigh Borough Council pursuant to arrangements with Hampshire County Council has made the above mentioned Traffic Regulation Order in exercise of the powers of the said County Council under Sections 1, 2, 4 of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act, and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act.

The effect of the Order is to:

1. Revoke in its entirety The Borough of Eastleigh (Hedge End, West End and Botley) (Amendment No 5) Order 2018.
  - a) Introduce 'No Waiting at Any Time' restrictions in the following roads: **Ivy Lane** both sides from Swaythling Road south-westwards for 19 metres; **Rosemount Court** north-west side from Swaythling Road north-eastwards for 5 metres, north-east side from 19 metres north of its south-eastern closed end north-westwards for 10 metres.
  - b) Remove 'No Waiting at Any Time' restrictions in **Rosemount Court** north-east side from its south-eastern closed end north-westwards for 19 metres, south-eastern closed end from the north-eastern kerblines south-westwards for 2 metres.

The Order will come into operation on 1 July 2019. A copy of the Order may be inspected at Eastleigh House, Upper Market Street, Eastleigh during normal office hours or on the Council's website: [www.eastleigh.gov.uk/TRO](http://www.eastleigh.gov.uk/TRO)

Any persons wishing to question the validity of this Order or any provisions contained in it on the grounds that any requirement of the Act, or any instrument made under that Act has not been complied with in relation to the Order, may within six weeks from 21 June 2019 apply to the High Court for this purpose.
